Get political buy in from the local Councillors, Are they in favour of the project.






How to overcome Resistance

Its all about influencing


Empower innovation and creativity give opportunities for feedback so that changes can be made to get to the end goal.






OBJECTIVE OF THE PROJECT

To review safety conditions for <u>all</u> road users and develop a road safety improvement scheme that will reduce the impact of traffic on the area, making it a safer environment for all.









COMMUNICATION & CONSULTATION PROCESS

- Dublin City Council had an extensive communication process which involved the following

- Public Meetings in Drumcondra library

- Reports made available in the Public Library and online on Dublin City Council Website.

OPTION DEVELOPMENT

Area Engineer conducted speed surveys, traffic counts and parking surveys

- 1. Staggered Parking,
- 2. Traffic signals at the bottom of Walsh Road/Ferguson Road,
- 3. Circuitous route,
- 4. Road Closure at the top of Walsh Road at the Home Farm junction,
- 5. Road Closure at the top of Ferguson at the Home Farm junction,
- 6. Road Closure on Millmount Avenue/Millbourne Avenue, closing off
 Millmount Avenue/Millbourne Avenue at the Ferguson Road junction






A Filtered Permeable Safe Cycle and Walking Route installed
